3.1. The exchange of staff members and for the purpose of education, study visit and training among the Parties.

3.2. The provision of training courses and study visits among the Parties.

3.3. Other forms of collaboration that are mutually determined by the Parties.

3.4. The expenses of proposed study visit and training program will be that:

3.4.1. each side bears the cost of international travel.

3.4.2. the host country is borne the in-country costs such as local transportation, meals and accommodation.

4. Matters of Concern

The Parties are required to consult on any matter raised by either Party with a view of resolution.

5. Commencement an Term

5.1. This Memorandum of Understanding takes effect from the date it is signed by two Parties and replaces any prior Memorandum of Understanding between two Parties in relation to like matters.

5.2. This Memorandum of Understanding will take effect from the date of its signing and shall be valid for a period of five years from that date unless sooner terminated or modified by mutal agreement between the Parties and may be extended by mutual agreement.

6. Financial Arrangements

All expenses relating to collaborative activities will be mutually determined by the Parties. In principle, the usual funding arrangement will be borne by fiscal budget of two Parties
