This Memorandum of Agreement is made and signed on Tuesday, July 25th 2019 in Chiang Mai, by and between:

1. **UNIVERSITAS INDONESIA**, an Institution of higher learning as university that organized by government based on government regulation No. 68 year 2013, domiciled at Jl. Salemba Raya 4, Jakarta. In this matter represented by **Prof. Dr. Ir. Muhammad Anis, M.Met.**, in his capacity as **Rector** pursuant to Decision of the Board of Trustees of Universitas Indonesia Number: 020/SK/MWA-UI/2014 and now therefore lawfully act for and on behalf of Universitas Indonesia, hereinafter shall be referred to as the **FIRST PARTY**; and
2. **THE RAJANAGARINDRA INSTITUTE OF CHILD DEVELOPMENT, DEPARTMENT OF MENTAL HEALTH, MINISTRY OF PUBLIC HEALTH, ROYAL THAI GOVERNMENT ("RICD"), 196 MOO 10, CHOTANA ROAD, DONKAEW, MAERIM, CHIANG MAI, THAILAND 50180**, represented by **Dr. Hathaichonnee Booncharoen, MD**, acting for and on behalf RICD, hereinafter shall be referred as the **SECOND PARTY**.

FIRST PARTY and **SECOND PARTY** altogether hereinafter shall be referred to as the **PARTIES**, and individually shall be referred to as the **PARTY**, hereby declared that they are agreed to enter into Memorandum of Agreement for the Program as mentioned above (hereinafter shall be referred to as the **MOU**) with provisions as follows:

**ARTICLE 1
PURPOSE**

The purpose of this MOU is to implement cooperation between **FIRST PARTY** and **SECOND PARTY** in education, research, and community service.

**ARTICLE 8
OTHERS**

- (1) In the event this MOU required any improvement, therefore revision of this MOU may be conducted based on written agreement signed by the PARTIES.
- (2) Problems arise in the implementation of this MOU will be settled amicably by way of deliberation to reach a consensus.

This MOU is made and signed by the PARTIES in 2 (two) original copies which each copies has the same legal power, one copy to be kept by FIRST PARTY and other copy to be kept by SECOND PARTY.
